The Return should be completely filled (all boxes should be completed). Where a response is not applicable enter n/a for text or zero (0) for value or number boxes.

COLUMN 1 – Description of Product Type / Revenue Line: Indicate the various supplies (goods and services) made within the given accounting period. This relates to the various revenue reporting lines of all the supplies made.

COLUMN 2 – Total Duration: Indicate the total duration of the various supply of electronic communication services in minutes/seconds.

Column 3 – Revenue: Relates to the revenue accrued from the supply of both electronic communication services (COLUMN 3A) and non-electronic communication services (COLUMN 3B).

Column 3A – Electronic Communication Services (ECS): Relates to communication service revenue accrued made up of peak, off peak provision electronic of communication services and usage (voice and/or data).

Column 3B – Non-electronic Communication Services (NCS): Relates to non-electronic communication revenue accrued within the given period.

COLUMN 4 – Total: Indicate the sum of both electronic communication and non-electronic communication services.

COLUMN 5 – Protocol & Promotions: Indicate in value the amount of electronic communication services supplied without charging the electronic communication services tax.
