is good at developing new and maintaining mutually beneficial internal and external relationships.

ATAF HOLDS AFRICAN TAX OUTLOOK VALIDATION WORKSHOP IN ACCRA

The African Tax Administration Forum (ATAF) has concluded its three-day African Tax Outlook (ATO) Validation Meeting at the Accra City Hotel, Ghana, with a strong call for enhanced data-driven tax administration across the continent. The event brought together 54 representatives from thirty-four ATAF member countries to discuss strategies for strengthening tax systems through comprehensive data analysis. The discussions focused on data collection, emerging trends in tax administration, and policy recommendations aimed at improving tax compliance and efficiency across Africa.

In his opening remarks, Mr. Frankie Mbuyamba, ATAF's Manager for the Regionalisation and Tax Research Information Platform (TRIP), applauded the Ghana Revenue Authority (GRA) for hosting the event. He emphasised the significance of data collection and analysis in strengthening tax administration, stating that the validation workshop builds on a collective effort that began in the previous year. "This engagement is a testament to Ghana's commitment to supporting tax administration reforms across the continent. The insights gathered here will provide key recommendations to broaden the tax base, enhance compliance, and improve overall tax administration," Mr. Mbuyamba stated.

Mr. Anthony K. Sarpong, Acting Commissioner-General GRA, in his keynote address, reaffirmed Ghana's commitment to tax administration reforms through collaboration and digital innovation. He emphasised the importance of leveraging technology and advanced analytics to enhance tax efficiency and compliance. He said, tax

administrators must embrace technology and data analytics to modernise tax systems. The ability to harness real-time data will significantly improve revenue mobilisation and drive economic development across Africa, "As tax administrators, we must embrace technology and data analytics to modernize our tax systems. Dr. Charles Addae, Deputy Commissioner for Strategy and Research at GRA, highlighted the pivotal role of tax data in shaping policy decisions. He noted that the forum provides an essential platform for African countries to evaluate tax administration performance, share best practices, and identify areas for improvement. "This forum is critical as it allows member countries to benchmark progress, analyze tax trends, and use data-driven insights to refine strategies. It is important that the data generated here is effectively utilized to enhance tax systems," he stressed.

Ms. Phindile Masuku, a member of the ATO team, officially launched the 2024 ATO Edition, providing an overview of the countries covered, tax performance trends, and insights on cost structures and human resource trends among tax administrations across Africa. She gave a brief overview of member countries, periods covered, and a general review of the tax performance of countries and regions. She also touched on cost and human resources trends and validation of results to project the efficient tax Administration functions across the ATO members.

Dr. Ezera Madzivanyika, Manager for Applied Research and Statistics at ATAF, presented on ATO indicators, validation processes, and ongoing studies. He elaborated on how ATO data and indicators contribute to ATAF's research publications and suggested innovative approaches for improving data collection, validation, and narrative

development. He also encouraged participants to share experiences and best practices, fostering a collaborative environment for knowledge exchange.

Dr. Charles Addae and Dr. Alex Kombat from the Ghana Revenue Authority made a presentation on the Ghana Excise Tax Stamp (ETS) Policy. They discussed extensively the implementation of the policy as a compliance and enforcement measure of the payment of excise taxes. Participants were given a practical understanding of affixing stamps to products, when they paid a working visit to the Kasapreko Company Limited, where they observed the affixing of Excise Tax Stamps on excisable products, providing practical insights into compliance enforcement.

The workshop provided a platform for participants to address challenges in tax administration and explore strategies for effective revenue management. Discussions centered on:

- Data-driven decision-making for improved tax administration
- Enhancing domestic resource mobilisation while ensuring fairness and transparency in tax policies
- Leveraging analytical tools for better revenue collection and compliance

GRA ENGAGES CHAMBERS OF COMMERCE ON SPECIAL VOLUNTARY DISCLOSURE PROGRAMME

The Ghana Revenue Authority (GRA) has engaged Chambers of Commerce in a strategic dialogue on the Special Voluntary Disclosure Programme (SVDP). The session aimed to educate participants on the programme's objectives, eligibility criteria, and application process while addressing concerns about compliance and transparency. By encouraging more taxpayers to take advantage of the SVDP, GRA seeks to align with global tax compliance standards and strengthen Ghana's revenue mobilisation efforts.

Mr. Joseph Asare, Accra East Area Director, on behalf of the Deputy Commissioner, Operations 2, welcomed participants and emphasised the government's commitment to financial transparency and accountability. He highlighted how international agreements on financial information exchange have enhanced tax authorities' ability to track offshore accounts, making the SVDP a timely and structured opportunity for individuals and businesses to regularise their tax affairs.

Delivering the keynote address, Deputy Commissioner for the Large Taxpayer Office (LTO), Mr. Robert Gbadegbe, explained that Ghana had transitioned from a source-based taxation system to a worldwide income taxation model. Consequently, resident persons earning foreign-sourced income are now required to declare and pay taxes on those earnings. He revealed that between 2021 and 2023, GRA obtained financial data from various international sources detailing offshore account balances held by Ghanaian residents. He stressed that the SVDP provides a unique opportunity for taxpayers to disclose their offshore income voluntarily while benefiting from waivers on penalties and criminal liabilities.

Mr. Paul Ahey, Head of the Automatic Exchange of Information (AEOI) Unit, outlined the programme's objectives and its role as a compliance tool for taxpayers with undeclared offshore assets. He also addressed key challenges, including misconceptions about the programme and the need for continuous stakeholder education.

Mr. Daniel Owusu provided clarity on the residency criteria for tax purposes, explaining who qualifies as a Ghanaian resident and is required to disclose offshore assets under the programme.

Mr. Jojo Abassa-Yankson conducted a hands-on session, demonstrating how to navigate the SVDP website and submit applications. This practical engagement was designed to simplify the process for potential applicants, ensuring compliance with tax regulations without difficulty.

The workshop served as an interactive platform, allowing stakeholders to seek clarifications and share insights on the effective implementation of the SVDP. GRA reaffirmed its commitment to collaborating with the business community to enhance voluntary compliance and strengthen Ghana's tax transparency framework. By fostering dialogue and providing clear guidance, the Authority aims to build trust and encourage taxpayers to fulfill their obligations, ultimately contributing to the country's economic stability and growth.

MODIFIED TAXATION: A GAME-CHANGER FOR GHANA'S INFORMAL SECTOR



Ghana's informal sector is a significant contributor to the country's economy, accounting for approximately 80% of the workforce. However, this sector has historically been characterised by low tax compliance, resulting in substantial revenue losses for the government.

In recent years, the Ghana Revenue Authority (GRA) has implemented modified taxation policies aimed at simplifying tax payment processes and encouraging voluntary compliance among informal sector operators.

What is Modified Taxation

Modified taxation refers to a tax system designed to accommodate the unique needs of the informal sector. It involves simplifying tax registration, filing, and payment processes, as well as reducing tax rates or providing exemptions for small businesses.

Benefits of Modified Taxation

The modified taxation policy offers numerous benefits to informal sector operators, including:

- Simplified tax compliance: Easy-to-use digital platforms and reduced paperwork make tax compliance more manageable
- Reduced tax burden: Lower tax rates or exemptions help minimise the financial strain on small businesses
- Increased access to credit: Tax-compliant businesses can access loans and other financial services, enabling them to expand their operations
- Improved business formalisation: Modified taxation encourages informal sector operators to formalise their businesses, providing a sense of security and legitimacy
- Improved tax enforcement and reduced GRA task force invigilation

Ghana's Experience with Modified Taxation

Ghana's modified taxation policy has shown promising results since its implementation. The GRA has:

- Introduced digital tax payment platforms: Online portals and mobile apps enable taxpayers to conveniently pay their taxes.
- Simplified tax registration: A one-stop-shop registration process reduces the complexity and time required for registration.
- Implemented tax education programmes: Workshops, seminars, town Hall meetings, and public awareness campaigns to educate taxpayers on their obligations and benefits
- Provided incentives for compliance: Tax-compliant businesses receive benefits, such as reduced tax rates, exemptions, or access to government contracts

Challenges and Future Directions

While Ghana's modified taxation policy has made significant strides, challenges persist:

- Limited awareness: Many informal sector operators remain unaware of the modified taxation policy and its benefits
- Technical issues: Digital platforms can be prone to technical glitches, hindering tax payment processes.
- Enforcement: Ensuring compliance among informal sector operators remains a challenge.

Future Directions/Possible Solutions to Address Challenges

- Intensify public awareness campaigns: Educate informal sector operators on the benefits and requirements of modified taxation
- Continuously improve digital platforms: Enhance the user experience, ensure technical stability, and expand access to digital platforms
- Strengthen enforcement mechanisms: Implement effective monitoring and enforcement strategies to encourage compliance
- Customer-centric approaches that promote win-win situations

Modified taxation has the potential to transform Ghana's informal sector by promoting voluntary compliance, reducing the tax burden, improving revenue mobilization through broader tax bases and reducing evasion, stimulating economic growth, enhancing transparency and accountability through the use of digital platforms, and improving taxpayer education and increasing access to loan credit. As the GRA continues to refine and implement this policy, it is essential to address the challenges that arise and ensure that the benefits of modified taxation are equitably distributed among informal sector operators.

By doing so, Ghana can unlock the full potential of its informal sector, driving economic growth, and improving the livelihoods of millions of Ghanaians.

CRIMINALISING TAX BREACHES - THE IMPACT AND THE WAY FORWARD



Introduction

The issue of criminalising tax breaches has generated a lot of views, not only in Ghana but also globally. There are schools of thought that favours criminalising tax crimes while others consider it inimical to effective revenue mobilisation.

This article is to assess whether the issue of criminalising tax breaches has any impact on tax compliance and revenue mobilisation in Ghana. It would also examine the case of using administrative penalties for tax breaches and conclude with pertinent recommendations.

The Constitution and the Tax Laws

In Ghana, taxes are administered by the Revenue Administration Act, 2016 (Act 915) together with other specific tax laws. This law defines tax in section (9) (1) as "A duty, levy, charge, rate, fee, fine, interest, penalty or any other amount imposed by tax law or to be collected by or paid to the Commissioner General under a tax law. Tax is thus a creation of law, specifically positive legislation.

Article 174 (1) (2) of Ghana's constitution provides as follows:

 No taxation shall be imposed otherwise than by or under the authority of an Act of Parliament 2. Where an Act enacted in accordance with the clause of this article, confers power on any person or authority to waive or vary a tax imposed by that Act, the exercise of power of waiver or variation, in favor of any person or authority, shall be subjected to the prior approval of Parliament by Resolution.

The above provision therefore makes it clear, that tax must necessarily be imposed according to positive law, specifically, an Act of Parliament.

Taxes and Revenue Mobilisation

The major reason for taxation is for the generation of government revenue. Thus, tax proceeds enable the government to fund its traditional functions of providing the enabling environments for its citizens to thrive. According to Justice Oliver Wendel Holmes a US supreme court justice "Taxes are what you pay for a civilised society". Thus, all living in a civilised world should contribute towards maintaining the state by paying taxes.

In Ghana, it is estimated that tax revenue constitutes about 70% of government revenue and close to 14.0% of gross domestic product (GDP). The above submission underscores the need to ensure payment of taxes as well as engendering voluntary compliance.

Generally, tax offences are classified as criminal or administrative depending on the statute governing tax administration. A crime is considered as conduct that is in breach of what is expressly prohibited by law. The Revenue Administrative Act thus classifies certain offences under administration and others under criminal offenses.



Criminalising Tax Breaches

The debate surrounding criminalisation of tax breaches in Ghana is of interest to note. This has become topical given the recent imposition of custodial punishment on some individuals for the breach of section 80 of the Ghana Revenue Administration Act 2016(Act 915). The proponent of criminalising breaches of tax laws justifies their stance by advancing the values below.

a. Deterrence:

It is imperative to establish standards of adherence to laws set out to govern any civilised society. Deterrence is an action of discouraging an action or event by instilling fear of the consequences.

Taxes are for the general well-being of each citizen of the state, thus, when it is established that an individual or institution deliberately infringes on tax laws, the punishment should be such that it will serve as a warning to potential offenders. It will thus act as a general deterrent and also a specific deterrent for the individual who has been convicted and sanctioned. Since criminal penalties such as fines and imprisonment are more punitive than Civil and Administrative Penalties, it will discourage others from engaging in such acts and in effect strengthening the credibility of the penal provisions.

b. For Revenue:

Another significant point raised to support the criminalisation of Tax breaches is the role taxation plays in the country. Chiefly among these is the Revenue Generation for development.

The crucial role of mobilising Revenue for the Government through taxes is paramount for the survival of Ghana. Thus, infringing on tax laws, positions such individuals or organisations as nation wreckers. This deliberate act of denying the state the needed revenue should be met with equal measure to ensure that the state is not denied the needed revenue.

c. Equity and Fairness:

One of the attributes of a thriving society is the ability to create a fair and just society. The nation Ghana is governed by laws with tax laws being no exception. Thus, the application and compliance with such laws will show a greater degree of fairness. In an instance where people comply and others blatantly refuse to comply will create an unfair system. To ensure equity and fairness in the system, criminalising Tax breaches is sane and desirable. Those who breach tax laws benefit at the expense of compliant taxpayers. By enforcing criminal notices and consequences fairly, we promote compliance, fairness, and the integrity of the justice system.

d. Economy Stability:

It is also pivotal to note that tax compliance is paramount for economic stability. It is therefore imperative for authorities to put in place mechanisms to maintain economic stability. It is worth noting that criminalising tax infractions will prevent the wastefulness inherent in human nature and thus preserve the economy to ensure the survival of the state.

e. Others Purposes:

The criminalisation of violations of tax laws also ensures the availability of criminal investigative and enforcement powers that are necessary to find the truth. The knowledge acquired will assist the country when the need for international collaboration arises.

Last but not least, criminalising Tax breaches depicts the determination of the country to protect the needed funds for the development of the country for the collective good of citizens. State authority is deepened when individuals are adequately punished for committing tax crimes.



Using Administrative Penalties

The above points notwithstanding, criminalising all tax breaches may be seen as excess. It is important to note that tax education in Ghana is not at the desirable level. The GRA is doing everything possible to reach out to all taxpayers and potential taxpayers to ensure they are educated about their responsibilities. This effort notwithstanding, tax knowledge is still inadequate thus the need to intensify tax education. It is worrying to note that there is no conscious effort to inculcate knowledge of taxes at the basic and secondary school levels. There is a need for a concerted effort to adopt a "catch them young approach" to inculcate these values and invariably reduce if not eliminate tax offences.

(i) Cases of Minor Offences: Criminalising tax breaches has the potential of overcriminalisation. Minor infractions may be unnecessarily criminalised causing unnecessary hardship for individuals or entities. The use of civil penalties may adequately address such issues.

- (ii) Discouraging Entrepreneurship: Criminalising Tax infractions may tend to discourage entrepreneurship and investment, a key ingredient for economic development. It is therefore better to resort to administrative sanctions than criminality. In October 2024, two (2) Managing Directors of different companies were found guilty of failing to pay Company Income Taxes (CIT) of their respective companies. This may serve as a drawback for business initiatives as well as an impetus for business owners to divert funds and their entrepreneurial skills elsewhere.
- (iii) Excessive Punishment: Furthermore, critics of criminalisation contend that criminalising tax issues may be overly punitive and also at variance with what is considered purely financial issues. They are also of the view that measures should be put in place to make it difficult for anyone to breach a tax law. Even in a situation where there is an infraction, the aim should be to retrieve the amount involved by civil actions. Thus, civil punishments are adequately punitive to deter potential offenders.
- (iv) Time Value of Money: There is also the view that the courts will be inundated with these breaches and it will take a long time to determine such cases. Given the time value of money, such delays may not augur well for the state. With the creation of the Independent Tax Appeals Board (ITAB), tax justice should not lead to incarceration.

Conclusion and Way Forward

It is in light of the above submission that strong views support criminalising tax breaches as well as opposition to that view. It must however be emphasised that when tax crimes are only handled administratively, achieving the desired goal of full voluntary compliance will not be realised. The state needs a coercive mechanism that will enable it to handle breaches while at the same time maintaining an enabling environment for individuals and businesses to thrive.

The Revenue Administration Act 2016. (Act 915) is designed to create a balance between criminalising some tax offences while treating other offences administratively. Sections 78 to 83 are structured to handle those offences as crimes that can lead to fines, imprisonment, or both. Sections 70 to 76 stipulate offences that are handled administratively.

The future of Ghana hinges on her ability to mobilise Revenue from taxes. This goal can be attained when infractions are adequately handled through criminal prosecution. As we seek to balance criminalising tax infractions and administrative redress, it will be prudent to ensure that the law adhere to it as it should to protect the nation.

EMPOWERING THE STUDENT ENTREPRENEUR: GRA PARTNERS BUDGIT GHANA & OXFAM GHANA IN A TAX AND LEGAL CLINIC



As a precursor to Tax and Good Governance Month in April, the Authority on March 14, 2025 participated in a tax and legal clinic organised by BudgIT Ghana, in collaboration with OXFAM Ghana, International Budget Partnership, and the Student Representative Councils (SRCs) of Universities to equip students' entrepreneurs with the knowledge to navigate the complex world of taxation.

Under the theme "Accelerate Action for Increased Domestic Revenue Mobilisation", the initiative seeks to empower student entrepreneurs to understand their responsibilities, ensuring that they contribute effectively to the development of a transparent and accountable society.

Mr. Victor Akogo Chief Revenue Officer in the Office of the Deputy Commissioner Operations 1 led discussions on the fundamental responsibilities of student entrepreneurs and provided valuable insights into the importance of taxes for nation building while guiding attendees on their taxpayers' obligations.

He underscored how tax revenue funds essential social services such as healthcare, education, infrastructure, and public safety. He also explained the different types of taxes that apply to small businesses, including income tax, Value added tax (VAT), and other local taxes that may be relevant depending on the type and size of the business and the processes involved in filing tax returns.

There was an open forum where participants posed questions and sought clarity to misgivings they had regarding their tax obligations, tax reliefs, and gift tax. For the student entrepreneurs in attendance, the event was an eye-opener, as many had never fully realised the wider societal benefits of tax compliance.

Despite these challenges, the revenue target for Tema Collection in 2023 saw a 43% increase compared to the previous year.

Challenges and Opportunities


While the RoO presents opportunities for trade facilitation and revenue mobilisation, there are challenges to be addressed. These include:

Aprapransa - A Forgotten Treasure of Ghanaian Cuisine

Once a beloved dish in many Ghanaian homes, **Aprapransa** is now rarely seen on modern menus. This rich and hearty forgotten delicacy, made from roasted cornmeal and flavoured with palm nut soup, was traditionally prepared for special occasions and served to elders as a delicacy.

With its nutty aroma, smoky fish, and velvety texture, Aprapransa is a reminder of Ghana's culinary heritage, one that deserves to be revived. If you're looking to enjoy a taste of the past or introduce younger generations to this forgotten treasure, this recipe is the perfect way to bring Aprapransa back to life!

Ingredients:

- 2 cups roasted cornmeal (egbb or akple flour)
- 2 cups palm nut soup (or palm cream)
- 1 cup groundnut paste
- 1 medium smoked fish (salmon, tilapia, or herrings)
- 1 small onion (chopped)
- 2 tablespoons dried shrimp powder
- 1 teaspoon ground pepper
- 1 teaspoon salt (to taste)
- 2 tablespoons powdered smoked fish (optional)
- 2 tablespoons vegetable or palm oil
- 1 boiled egg (for garnishing)

Instructions:

- **Prepare the base** In a pot, heat palm nut soup and add groundnut paste. Stir well to combine. Let it simmer for about 5 minutes on low heat.
- **Season the mixture** Add the chopped onion, dried shrimp powder, ground pepper, and salt. Stir and let it cook for another 5 minutes.
- Add fish and flavour Remove bones from the smoked fish, break it into pieces, and add to the pot. Add the powdered smoked fish (if using) for extra flavor.
- Add in the roasted cornmeal Gradually sprinkle the roasted cornmeal into the soup while stirring continuously to prevent lumps. Keep stirring until it thickens into a smooth, stiff consistency.
- **Final touch** Drizzle a little palm oil over it for extra flavor. Stir well and let it sit for a few minutes on low heat.
- Serve hot with a boiled egg on top. You can also accompany the aprapransa with chilled Sobolo (Hibiscus drink) or Asaana (Corn drink)
